7A: Motion Renewing an Employment Agreement with the Police Chief

Township Manager Stanick reported that before the Board is an employment agreement with Police Chief Hilk for the 2021 year with an annual salary of \$92,003.18 (salary increase for 2021 is 3.25%, reflective of the wage increase for police officers for 2021 as the contract states).

7B: Resolution Setting the Salary for the Township Manager in 2021

Township Manager Stanick reported that pursuant to Section 1301 of the Second-Class Township Code, as well as Township Ordinance #2-88, the compensation of the Township Manager is to be set by Resolution each year. He noted that attached for the Board's consideration is a Resolution Setting the Township Manager's Salary for 2021 at \$93,359.20

Mr. Murphy moved to approve a Resolution setting the Salary for the Township Manager in 2021 at \$93,359.20. Mr. Luketich seconded the motion. The motion passed on a unanimous voice vote.
