2. MOTION APPROVING AN APPLICATION BY FOX JR. DEVELOPMENT, INC. REQUESTING A USE BY SPECIAL EXCEPTION FOR THE PROPERTY LOCATED AT 1075 E. BEAU STREET IN THE R-1 RESIDENTIAL ZONING DISTRICT TO CHANGE THE USE FROM DELICATESSEN TO CARRY-OUT RESTAURANT
